

## **Marketing Feedback Consent Statement**

When providing feedback about Upskill Services Ltd, you will be asked to grant approval for us to use the information that you provide us in line with The Consent Statement.

It is imperative that you grant written approval yourself and that you do not impersonate anybody else.

Your consent may be captured through email communication or through a recorded video or audio conversation, and it will be made clear to you that your consent to use your feedback for marketing purposes is in line with The Consent Statement.

## The Consent Statement

1. By responding to our request for your consent via written communication, you enter into this Agreement with Upskill Services Ltd. You have been informed and understand that Upskill Services Ltd may wish to produce videos and/or images that contain your name, likeness, image, voice, appearance, job title and organisational name.
2. You accept that any feedback that you provide and anything associated with your journey may be shared in print or digital format for marketing purposes by Upskill Services Ltd.
3. You also accept that if Upskill Services Ltd wish to make further productions based on your journey, name, likeness, image, voice, appearance, job title and organisational name, this may be recorded and adapted as part of any production, hereafter referenced to as "Production".
4. You grant Upskill Services Ltd and its designees the right to use your name, likeness, image, voice, appearance, and performance as embodied in the Production whether recorded on or transferred to videotape, video files, film, slides, photographs, audio tapes, or other media, now known or later developed.
5. This grant includes without limitation the right to edit, mix or duplicate and to use or reuse the Production in whole or part as Upskill Services Ltd may elect. Upskill Services Ltd shall have complete ownership of the Production in which you appear, including copyright interests, and you acknowledge that you have no interest or ownership in the Production or its copyright.

7. You confirm that you have the right to enter into this Agreement, that you are not restricted by any commitments to their parties, and that Upskill Services Ltd has no financial commitment or obligations to you as a result of this Agreement.
8. You hereby give all clearances, copyright and otherwise, for use of your name likeness, image, voice, appearance, job title and organisational name embodied in the Production. You expressly release and indemnify Upskill Services Ltd and its officers, employees, agents and designees from any and all claims known and unknown arising out of or in any way connected with the above granted uses and representations. The rights granted to Upskill Services Ltd herein are perpetual and worldwide. You confirm that your permission as granted under this agreement will supersede your death and that your next of kin is aware of this.
